The District Council had confirmed that no requests for election had been received so Angela Joy was co-opted onto the Council to fill the vacancy caused by Sarah Tevendale's resignation. The Councillors were sorry to receive Bill Holmes' resignation, due to work commitments, and this vacancy will be advertised.

DECLARATIONS OF INTEREST

There were no declarations of interest.

PARISH WEBSITE

Ian Hawkins was welcomed to the meeting to discuss the village website, which was set up about ten years ago. The Parish Council is very grateful to Ian for maintaining it and he said the most difficult part is keeping it up to date. He wondered if anyone would like to volunteer to help him and the Parish Council would like to encourage village organisations to keep him informed regularly about their groups.

MINUTES The Minutes of the previous meeting were confirmed and signed.

MATTERS ARISING

<u>Highways</u> Cllr Wakely spoke of an accident which had occurred as a result of the potholes on the road to Lopen Head. The County Councillor will ensure that the Highway Authority is aware of this. Gary Warren will be reminded to contact Cllr Bishop in respect of a white line which has been positioned incorrectly.

DC REPORT

Adam Dance said the District Council had appointed a new Chief Executive, who will start on 3 October.

CC REPORT

Christopher Le Hardy had spent a day with the South West Ambulance Service, who have an eight minute target for reaching those requiring assistance.

If the Parish Council is thinking of getting a defibrillator, Adam Dance felt there may be a possibility of a District Council grant so the Clerk will send him a formal request.
